Our club's charitable Foundation was founded in 1994, and is a tax-exempt charitable organization under section 501(c)-3 of the Internal Revenue code. It was created to provide financial assistance to deserving individuals who need assistance in pursuing their educational goals, and to support worthy community, national and international projects.

Under the By-laws of the Foundation, the President of the club, and the three immediate Past Presidents, serve on the Foundation Board. The Treasurer is appointed by the Board, and there are two "at large" directors elected by the Board.

The Foundation is funded by monies raised by the club in its fund-raising activities, as well as individual tax-deductible donations from members and friends.

A Brief History

The Rotary Club of North Bethesda, chartered by Rotary International in March, 1974, is one of 69 clubs in Rotary District 7620. It was the first breakfast club in the metropolitan-Washington area. The founders believed that our meeting time -7:30 to 8:30 a.m.- would be convenient for both Rotarians and guest speakers.

The commitment, energy and standards set by the Charter Members remains just as strong today as it was in the beginning. The 26 founders, drawn from the local business and residential community, can take pride in what they started in 1974. While most have moved from the area, a few still remain Joseph Bunker, Donald Howard, Kent Mason and Tas Tousimis.

In 1994, the club formed the Rotary Charitable Foundation of North Bethesda to facilitate the distribution of funds to worthwhile causes, and at the same time establish an IRS-approved organization for tax-deductible gifts. All of the club's fund raising activities are funneled through this foundation.

The club's community service programs over the years has taken many forms, including raising funds for college scholarships, making donations to many local projects, on-going support of St. Luke's House work with people with mental illness, and on and on. In addition, there have been numerous international involvements—from Tanzania to Sri Lanka and to India!
